UNITED WAY ENDOWMENT FUND

To build the sustainable future for United Way of Johnson & Washington Counties.

UNITED WAY ENTREPRENEURIAL FUND

Established by Casey Cook to build the pool of United Way grants that support innovative approaches to solving community priorities and emerging issues.

UNITED WAY HEALTHY KIDS ENDOWMENT FUND

To generate sustainable funding for school-based health clinics. United Way has provided annual operating support for the Healthy Kids clinics since 2006 and works with the Healthy Kids partners to raise funds for the endowment through the annual "Get Moving for Healthy Kids" walk/run.

UNITED WAY SUMMERSHIP ENDOWMENT FUND

Established by United Way of Johnson & Washington Counties and the Community Foundation of Johnson County to help more kids in our community have access to high quality, enriching out of school programs. The goal of Summerships is to annually provide camp scholarships for up to \$250 each for 84 kids eligible for free and reduced lunch who otherwise could not afford to go to camp.

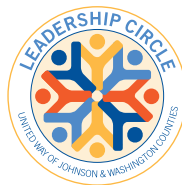
